CRICKET PLAYING SURVEY 2022

PRIZE DRAW TERMS AND CONDITIONS

Prize Draw Overview

- 1. England and Wales Cricket Board Limited, a company incorporated and registered in England and Wales with company number 03251364, and having its registered office at Lord's Ground, St. John's Wood, London, NW8 8QZ (the "ECB"), is organising and operating four optional prize draws for a chance to win certain prizes (described in paragraph 9 below) following the completion of a cricket playing survey (the "Survey") (each a "Prize Draw").
- 2. Prize Draw entrants ("Entrant(s)") are deemed to have accepted, and agreed to be bound by, these terms and conditions Draw (the "Prize Draw Terms and Conditions") upon entry into any Prize Draw(s). A copy of these Prize Draw Terms and Conditions will be posted on the ECB's website at www.ecb.co.uk (the "Website").
- **3.** The decision of the ECB regarding any aspect of a Prize Draw is final and binding (including as to the award of the Prizes) and no correspondence will be entered into regarding any such decision.

Entry Process

- 4. The Survey and each Prize Draw will be open for entry between 09:00am on Wednesday 17th August 2022 and 23.59 am on Monday 5th September 2022 (the "Entry Period"). Any entries received outside of the Entry Period and/or other than in accordance with the entry requirements set out in these Prize Draw Terms and Conditions will not be considered.
- 5. Each Prize Draw is open to all individuals aged 14 years and over within the United Kingdom who successfully complete the Survey and tick the box to confirm that they wish to be entered into one or more of the Prize Draws. Entrants must select the individual box for each Prize Draw (up to a maximum of all 4 Prize Draws) they wish to enter. Any Entrants under the age of 18 must obtain the written consent of their parent and/or guardian to enter any Prize Draw and to claim any Prize (as defined below). Employees of the ECB are not eligible to enter any of the Prize Draws.
- 6. To enter a Prize Draw, individuals must access the Survey via their email, Facebook, Instagram, Twitter and/or through the Website and complete the Survey online. Entrants must enter their contact details at the end of the Survey and select which Prize Draw(s) they wish to enter. Entries will not be accepted by any other means.
- **7.** Each Prize Draw is free to enter, and no purchase is necessary. Only one (1) entry to each Prize Draw per Entrant is permitted.
- 8. In entering a Prize Draw, each Entrant confirms that they are eligible to do so and eligible to claim the Prize that they may win. The ECB may require an Entrant to provide proof that they are eligible to enter the Prize Draw(s) (including proof of age and/or proof of their parent's or guardian's consent).

Prize

- **9.** Each of the four Prize Draws has its own prize(s) and Entrants have the chance to win:
 - One of two women's softball kit and equipment bags (Prize Draw 1 two winners)

- One pair of tickets to England vs India Women's ODI at Lord's Cricket Ground on 24th September 2022 (Prize Draw 2 – one winner)
- One England Men's Test Team signed shirt (Prize Draw 3 one winner)
- One England Women's Test Team signed shirt (Prize Draw 4 one winner)

each a "Prize", together the "Prizes".

- **10.** The ECB will select each winning Entrant at random via a computer-generated selection process on or soon after Tuesday 6th September 2022 (the "**Draw Date**"). Each winning Entrant will be notified (as soon as reasonably practicable after the Draw Date) using the contact details provided on entry into the relevant Prize Draw(s).
- **11.** Each winning Entrant must confirm that they are able to accept the relevant Prize within the time specified in the ECB's Prize notification. In the event that any winning Entrant fails to confirm their acceptance of the relevant Prize by this date, or is unable to accept the Prize that they have won for any reason, or the ECB determines that the relevant winner has breached these Prize Draw Terms and Conditions, the ECB reserves the right to offer the relevant Prize to another Entrant selected at random. The ECB does not accept any responsibility for failure by any winner(s) to claim their Prize.
- 12. ECB will endeavour to deliver the relevant Prize to a winning Entrant within 2 months from the date of acceptance of such Prize but shall not be responsible for any delay in delivery. Each Prize is non-exchangeable and non-transferable and no cash alternative is offered. A Prize does not include anything not expressly set out in these Prize Draw Terms and Conditions, including but not limited to, associated travel and accommodation or other general expenses.
- **13.** The ECB reserves the right to substitute each/any winner's Prize for an alternative prize of equal or greater value if necessary (in the ECB's sole discretion).

Limitation of Liability

- 14. None of ECB, nor any of their affiliates, agents, employees, officers, directors or representatives will be liable (to the extent permitted by law) for any direct, indirect or consequential loss or damage arising out of the organising or holding of the Prize Draws or as a result of any Entrant's participation in any Prize Draw or as a result of the winning, collecting, use or enjoyment of any Prize, or if any of the Prize Draws do not run as planned or if any part of any prize is unable to be delivered for any reason. Prize Draw Entrants' statutory rights are not affected.
- **15.** If any Prize Draw or any part of it is not capable of running or being completed as planned for any reason, including but not limited to reasons of infection by computer virus, bugs, tampering, unauthorised intervention, technical failures or any other causes beyond the control of the ECB, the ECB reserves the right to cancel, terminate, modify or suspend the relevant Prize Draw without liability.
- 16. The ECB accepts no responsibility or liability for any Prize Draw entries that are outside of the Entry Period, delayed or otherwise not successfully completed, regardless of cause, including (without limitation) due to a technical fault, technical malfunction, computer hardware or software failure, satellite, network or server failure, of any kind.
- **17.** These Prize Draw Terms and Conditions will apply unless expressly stated or varied by the ECB.

18. Each Entrant warrants that they have permission to use any mobile telephone or any other device used to access the Internet for the purposes of entering the Prize Draw(s).

Entrants' Personal Data

- **19.** Each Entrant acknowledges that their contact details will be used by the ECB for the purposes of operating the Prize Draw(s) and administrating Prizes. By entering any Prize Draw, each Entrant acknowledges and understands that the ECB shall use personal data supplied during the course of the Prize Draw in accordance with all applicable data protection laws, its privacy policy (available at https://www.ecb.co.uk/privacy), the Privacy Notice served to participants of the Survey, and these Prize Draw Terms and Conditions.
- **20.** Each winning Entrant may be required to participate in publicity related to the Prize Draw(s) and the ECB reserves the right to use, the name, image, and town and county of residence of each winning Entrant in any media for such promotional purposes.

- **23.** Each Prize Draw, the Prize Draw Terms and Conditions, and any non-contractual obligations arising out of them will be governed by English law and all Entrants submit to the exclusive jurisdiction of the English courts.
